The present day Hazen Motor Company had its beginning in 1944, when Otto Huber purchased auto repair equipment from Leonard Wohlfeil. Elthor Huber, Otto's brother, joined him in 1946. They then purchased the Barthel and Buri Chevrolet and Case dealership, which was located in the present Promiseland building. Sons, Howard and Eugene, joined the family operation in the early 50/s. In 1957, the Huber's added Pontiac and Buick car lines, New Holland farm equipment and other short lines of implements. Elthor moved to Stanley in 1959 where he operated a Chevy and Buick dealership. A showroom was added in 1965 and in 1972 they expanded the shop area. The farm equipment shop moved out on the bypass in 1979. Steve Huber and Barb Finneman joined the family business at that time. In 2012, an extensive building update took place which brought us into the 21st century. We are very proud to be a Hazen business for 70 plus years and counting.



